DOC, in coordination with DOD, DHS. DNI, and DOE, shall:

- analyze semiconductor design and production capacity domestically and by allies or partner countries:
- assess the risks of products or services in Federal systems:
- assess the risk posed by the presence of such products or services in Federal contractor/subcontractor supply chains, including for non-Federal systems;
- develop a strategy; and
- provide the results to FASC.

August 2023

Section 5949(i)

DOC reports to Congress on:

- 5949(e) findings and recommendations: and
- 5949(f) traceability and diversification initiative.

December 2024

Section 5949(g)

FASC, in consultation with DOC, DOD, DHS, DNI, and DOE, and after private sector engagement, shall:

- issue recommendations to mitigate supply chain risks to Federal acquisition of covered products and services; and
- make regulatory recommendations to FARC on risk mitigation.

December 2025

Section 5949(c)

FARC shall issue regulations implementing Section 5949's prohibitions, including a requirement for prime contractors to incorporate the substance of such prohibitions and applicable implementing contract clauses into contracts for the supply of electronic parts and products. **Industry should have** opportunity to provide comments on rulemaking activity prior to issuance of regulations implementing Section 5949's prohibitions.

December 2027

Section 5949(a)

- Federal agencies may not procure, obtain. or renew contracts for certain products or services that include semiconductor products or services "designed, produced, or provided" by SMIC, CXMT, or YMTC.
- Federal agencies may not enter into contracts, or extend or renew contracts. with an entity to procure or obtain certain parts or products that use any electronic parts or products in critical systems, that include products or services from SMIC, CXMT. or YMTC.
